The Presidential Decree No 19-108 of 26 March 2019 ratified the agreement of financial cooperation between the Government of the Democratic Republic of Algeria and the Government of the Republic of Cuba, signed in Algiers, on 25 January 2018.

The Declaration of 3rd April 2019 pronounced the definitive vacancy of the Presidency of the Republic.

- The Executive Decree No 19-112 of 1st April 2019 amended and supplemented the Executive Decree No 92-07 of 4th January 1992, on the legal status of social security funds and the administrative and financial organization of social security.

- The Executive Decree No 19-113 of 1st April 2019 amended and supplemented the Executive Decree No 93-119 of 15 May 1993, setting the powers, the organization and the administrative functioning of the national social security fund for non-salaried.

The Executive Decree No 19-122 of 9 April 2019 amended and supplemented the Executive Decree No 04-331 of 18 October 2004, regulating the activities of manufacture, import and distribution of tobacco products.

The Inter-ministerial Order of 28 February 2019 amended and supplemented the inter-ministerial Order of 17 June 2014, approving the specifications setting the public service obligations entrusted to the national agency to the development and attractiveness of the territories.

- The Order of 2nd December 2018 adopted the rules of procedure of the unfair terms commission, in application of the article 6, paragraph 3, of the Executive Decree No 06-306 of 10 September 2006, amended and supplemented, setting the essential elements of contracts concluded between economic agents and consumers and the terms considered as unfair .

- The Order of 8 April 2019 amended the Order of 26 January 2019, setting the list of goods subject to the provisional additional safeguard tax and the corresponding rates.

The Order of 17 October 2018 approved the salary and material indices of the 2nd quarter of 2018, used in the formulas for updating and reviewing the prices of works contracts in the sector of construction, public works and hydraulics (BTPH), in application of the articles 102 and 103 of the Presidential Decree No 15-247 of 16 September 2015, on the regulation of public procurements and public service delegations.
