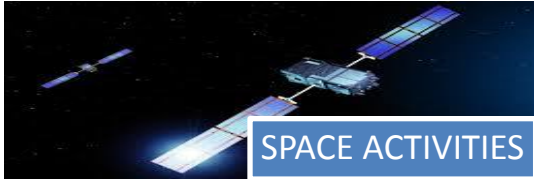
The Law No 19-04 of 17 July 2019 amended and supplemented the Law No 98-06 of 27 June 1998, setting general rules of civil aviation.
