

In addition to its energy and natural resources prowess, the team has further experience in TMT, intellectual property and project finance. It is a popular choice among leading international law firms seeking local counsel for construction disputes and a wealth of other matters.

Amine Ghellal is considered "an oil and gas expert" and is a pre-eminent lawyer in Algeria. He is esteemed for his abilities in international arbitration and is well versed in a range of projects and energy work, including project financing.
